4. Donation Agreement:

As a symbolic gesture of gratitude and support for the longevity of the Christ Soul Winners Ministry grant program, you agree to the following:

a. Repay 50% of the grant (flat rate \$1500) to Christ Soul Winners Ministry to help fund publishing projects for other incarcerated aspiring authors. You will do this through royalties earned from book sales.

b. Begin repayment of the grant 90 days following the official release of your book project. Your book will be listed in the Comeback Season Publishing bookstore. A marketing and promotional strategy will be established to announce the release of your book and help boost sales in the first 30 days. After the initial release and marketing boost, your book will remain in the bookstore for the life of the book. Sales will be calculated monthly, and a detailed report will be provided to the author every quarter. Royalties will also be paid quarterly, with 20% going to Comeback Season Publishing, 20% going to The BDA Foundation, and 60% going to the author. Of your 60%, 30% will go to Christ Soul Winners Ministry until the repayment obligation is completed. The remaining 30% will be paid to you, the author, to an account you authorize. Here is the royalty payment breakdown:

Author - 30% (60% when grant repayment is completed)

Christ Soul Winners Ministry - 30% (until \$1500 repaid)

Comeback Season Publishing - 20%

The Before/During/After Foundation - 20%

5. Impact Reporting:

You may be asked to provide a short testimonial, letter of thanks, or story excerpt to be used in reports or promotional materials that highlight the impact of this grant.
